**MW** opened meeting at 7.35 pm and:

- 1. Welcomed new member Lewis Jarvis, son of Lester , and
- 2. Apologised for the "mess ups" on the Presentation Night held at RCGC on 15<sup>th</sup> April.

## Captain Karl F

1, Circulated a blackout.

**2.** Thanked Jason G and Eric B for hosting his opening outing the Bunny Run at Wickham – won by GG with James M as runner up – followed by presentations and cakes at the Funtley Club- following which they donated £200 raised on the day towards his nominated Charity - **MND**.

**3.** Commented on the fun had by all those who attended Lester's stag trip at Wokefield Park and thanked those who had donated from their winnings another £250 to his nominated Charity.

**4.** Reported that, having received reassurances from Pete F that there would definitely be 7 tee slots for the proposed Steve Gill memorial event on 8<sup>th</sup> May, had already got the requisite 28 names of which 27 members with one guest of Des (Roy Harding ).

After some discussion and on basis it is intended will be an annual event going forward was agreed it would form part of OOM with best 8 scores counting.

5. Circulated sign-up sheets for:

charity "Papyrus", a donation to Rowans hospice in memory of Steve Gill with possible Memorial Bench and/or tree pending response from Club committee, donation to family of Claire in halfway hut, and a contribution to the Elizabeth Foundation which had been back in touch having apparently been the nominated Charity of in Darren G's year.

That leaves just shy of £2k still available if anyone knows of any worthwhile and local good causes- at which point there was a query as to whether there is a Defibrillator on site at the Club and if not whether we should consider covering cost of providing one (refer to Pete F to check).

- c) Confirmed that will be keeping funds separate for Karl F,s nominated Charity MND.
- d) Reiterated comments following discussion at the AGM about being slightly less specific in future events to allow more discretion for spreading monies raised amongst various causes and applying likes of raffle takings back into Society funds.
